Mary Deeter, called the meeting to order at 4:00 p.m. in the Martha Jorden room at 1605 County Road 1095, Ashland.

#### I. CHAIRPERSON'S WELCOME

Mary indicated that the family directly across from us (on the other side of the driveway) had a house fire last week and lost everything, a sheet is in the packet and was distributed tonight with the needs of the family for those who would like to help the family.

Mary explained that last month we flipped the agenda and lead with the voting items first so that Chad could leave since he was sick. This month Andy is sick, and we could have had to do the same thing, therefore, to prevent this in the future the order of the agenda will be changed going forward.

A. Roll Call- Mary Deeter took roll call in the absence of Secretary Katie Wright, and a quorum was present. There was a quorum to pass the warrants.

## APPROVAL OF THE SEPTEMBER 24, 2024, BOARD MINUTES

A motion was made by Tom Gaus to recommend approval of the September 24, 2024, Board meeting minutes. Connie Butler seconded the motion. The motion carried.

#### III. NEW BUSINESS

## A. PLANNING, Sara Battison, Chair

#### i. SUD Advisory Committee Updates

David Ross, Executive Director, indicated the substance use disorder (SUD) Advisory Committee meets monthly, and the local agency members like ACCADA, the hospital, health department, and others discuss what is being done about substance use in Ashland County. At the meeting last Friday, Kurt Schneider, Sheriff Elect, was on the agenda to discuss the Boarder issues. Kurt, and Matt and Melanie Miller went down to the Boarder to see what is

happening daily on the frontlines. Both the Times Gazette and the Ashland Source covered the story. Kurt was focused on the Fentanyl problems and our community, and he is seeing the need for more and more services. Kurt would like to do more programming in the jail, such as strengthening linkage to ensure people are connected to mental health and alcohol and drug services. He sees the value in our services and recognizes it helps his staff with the work they do.

#### ii. Ohio Medicaid 1115 Reentry Demonstration Waiver

David explained that the federal government has made an opportunity for organizations to get a waiver for 30-60 or 90 days while in jail. Before leaving the jail, it would allow for increased services.

## iii. <u>Video Series: Ohio First Responders Impacted by Suicide</u>

Steve Click has done training for us in the past and is the Director of First Responder Wellness. He has developed a video series with suicide resources for agencies and first responders. We will be linking our first responders with this video series.

Sara noted that it is sad to know that the first responders who help so many people are struggling themselves. She is glad to know this resource is out there for them.

#### iv. Training & Event Updates

- Loudonville Street Fair a Success, Thank you. Board members agreed and discussed many good things that happened during the week.
- The World Mental Health Day event at AU- Mary Deeter attended the event with Sandy. The students were very receptive and picked up materials and giveaways.
- Trust-Based Relational Intervention (TBRI) Training in Process
- Seeds of Hope Creative Expanses Art Display- Connie attended and was very impressed with the event. David indicated the event was packed, which indicates that we need to be open to the need for art therapy.
- Volleyball Game- Ashey provided resources during the game, and material was being picked up.
- David noted that the new President at the College is seeing the value in our work and our partnership with them.
- Suicide Prevention Coalition Meeting- The meeting happens twice a year, it was via zoom, however, we may have it in person next time.
- Regional Out of Darkness Walk- David attended the event and he noted that the Huron County Board was also in attendance.
- Ashland High School Suicide Prevention Event- Bella, MHRB Intern and Ashley
  distributed suicide prevention resources during the lunch period. They had some
  conversations with students. This was the first time that we had an event like this in
  high school.
- David discussed the fact that our internship and event in the high school is a good way to increase the workforce for our field, which is very important.

## B. FINANCE, Chad Brown, Chair

#### October Warrants

A motion was made by Sara Battison to recommend approval of the October 2024 warrants for payment. Cindy Kyser seconded the motion. The motion carried.

## II. <u>September Financials</u>

Patty reported that we are three months into the new year, first quarter of FY25. Target is 25 percent. Revenues are running a little higher than target, but this is expected and based on timing. Overall expenses for the agencies are trending at or above target. Non-Medicaid is trending below target. Overall Boad expenses are a little above target. We just finished up the fairs, the suicide prevention awareness walk, preparing for the annual luncheon, so our programmatic expenses are higher than usual. We have lots of activities going on. There has also been an increase from several of our vendors.

### III. SFY 2024 Closeout & Carryover Discussion

Referring to the SFY 2024 Closeout, Patty reported \$576,574 as carryover. She explained that FY25 differences and intent of proposed dollars are identified. She pointed out the difference in salaries and operating/services is based on our polices. She explained that the difference in IT/Capital Match is for capital projects, we have set the dollars aside for the possible purchase of the house next door. We believe the house is in probate currently. General Reserves were increased for possible use at mid-year if necessary. And the FY25 budget line would add monies for some necessary updates at the Board offices and at the Professional Building. There was also funds to balance the FY25 budget.

Tom Gaus made a motion to approve the FY25 Carryover of \$576,574.94. Connie Butler seconded the motion. The motion carried.

## IV. Grant Funding Updates

David reminded the Board that the Ohio Foundation grant process is highly competitive. We have heard that one of our requests was approved. Rick Ford, Director of ACCADA, is one of our agencies that was contacted. ACCADA's quick response team (QRT) program was approved for 3 years.

Although we have been notified the results for SOS 4.0 are in, the governor's office is waiting to announce the awards. It's concerning as we have people and programs that depend on the dollars for programming, which puts clients at risk. We will need to wait and see about whether any of our requests were supported.

#### V. CCS Audit

Patty indicated we received the CCS Audit and there were no findings. We have a copy of the audit if anyone wants to see it. No action is necessary.

## VI. 2023 Ashland County Audit

Patty reported that the 2023 Ashland County Audit was also received with no findings. The Audit can be seen on the Auditor's website.

David reminded Board members that those who didn't attend the Mandatory Board training need to complete the training. An email went out with a link to watch the video and then attest that it was completed.
